SUMMARY & BACKGROUND:

The Toledo-Lucas County Victim-Witness Assistance Program has requested funding to continue its services to residents of Toledo and Lucas County. The Toledo-Lucas County Victim-Witness Assistance Program assists victims of violent crime as they go through the criminal justice process. This ordinance authorizes the expenditure of \$40,000 for the contribution from the Police Law Enforcement Trust Fund. There are no impacts on general fund expenses or revenues.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to provide a contribution of \$40,000 to the Toledo-Lucas County Victim-Witness Assistance Program.

SECTION 2. That the sum of \$40,000 is authorized for expenditure from Account Code 2090-52000-3T32302STDSLC (Law Enforcement Trust Fund) as a contribution to the Toledo-Lucas County Victim-Witness Assistance Program.

The reason for the emergency lies in the fact that it is necessary for the mediate preservation of the public peace, health, safety, and property, and in order for the City to make the mediate preservation to the Toledo-Lucas County Victim-Witness Assistance Program.	he
