Authorizing the Mayor to accept and deposit grant funds from the Criminal Justice Coordinating Council (CJCC) for the United States Department of Justice/Bureau of Justice Assistance/Edward Byrne Memorial Justice Assistance Grant Program in the amount of \$147,167; authorizing the appropriation and expenditure of funds from the Operation Grants fund; authorizing the Mayor to accept bids and award contracts; and declaring an emergency.

SUMMARY & BACKGROUND:

This ordinance authorizes the acceptance, deposit, appropriation, and expenditure of \$147,167 from the United States Department of Justice/ Bureau of Justice Assistance/Edward Byrne Memorial Justice Assistance Grant Program. The grant is for the purchase of Modular Lightweight Load-carrying Equipment (MOLLE) body armor vests. There is no local match to receive the grant.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into a grant agreement and to accept and deposit grant funds from the Criminal Justice Coordinating Council (originating from the United States Department of Justice/ Bureau of Justice Assistance/Edward Byrne Memorial Justice Assistance Grant Program 2023-JG-LE-1000 Federal Justice Assistance Grant) in the amount of \$147,167 into the Operation Grants Funds Account Code 2016-52000-3G07718STDSTD.

SECTION 2. That the amount not to exceed \$147,167 is authorized for appropriation from the unappropriated grant proceeds of the Operation Grants Fund to Account Code 2016-52000-3G07718STDSTD and the expenditure of same is authorized for the purchase of Modular Lightweight Load-carrying Equipment (MOLLE) body armor vests.

SECTION 3. That the Mayor is authorized to accept bids and award contracts for the purposes authorized in Section 2, upon terms and conditions acceptable to the Director of Police and the Director of Law.

SECTION 4. That the Finance Director is authorized to draw a warrant or warrants against the above-mentioned Account Code in an amount not to exceed \$147,167 in payment of the obligations authorized above by the terms of the grant upon presentation of the proper voucher or vouchers.

SECTION 5. This Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that it is necessary for the immediate preservation of the public peace, health, safety, and property, and to expedite the receipt and expenditure of grant funding.
