DPU120523COLLINSPARK Environmental Services Abed Semaan (x3951) Revised

Authorizing the Mayor to enter into and execute necessary agreements with the Great Lakes Commission (GLC) as subgranted from the National Oceanic and Atmospheric Administration (NOAA) through a Cooperative Agreement with the U.S. Department of Commerce Award "Regional Partnership to Restore Fish Habitat in Priority Great Lake Coastal Sites and Areas of Concern"; authorizing the Mayor to accept and deposit grant proceeds in the amount of \$175,100 into the Operation Grants Fund; authorizing the appropriation and expenditure of said grant proceeds for the Collins Park Stream Restoration Engineering & Design project; authorizing the mayor to accept bids and execute necessary agreements and contracts for the purchase of goods and services to administer the grant; and declaring an emergency.

SUMMARY & BACKGROUND:

The City of Toledo has been awarded funding and is invited to enter into a subgrant agreement with the Great Lakes Commission (GLC) in coordination with the National Oceanic and Atmospheric Administration (NOAA) for a U.S. Department of Commerce grant in the amount of \$175,100 to be used for the Collins Park Stream Restoration Engineering & Design project. This ordinance authorizes the mayor to accept, deposit, appropriate and expend up to \$175,100 in grant proceeds from the Great Lakes Commission (GLC).

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into a grant agreement with the GLC for the Collins Park Stream Restoration Engineering & Design project, upon terms and conditions acceptable to the Director of Public Utilities and the Director of Law.

SECTION 2. That the Mayor is authorized to accept and deposit grant proceeds in an amount not to exceed \$175,100 into the Operation Grants Fund in Account Code 2016-38000-6G00309STDSTD, for the purpose of completing work necessary to administer the grant authorized in Section 1.

SECTION 3. That the appropriation from the unappropriated grant proceeds in an amount not to exceed \$175,100 is authorized from the Operation Grants Fund into Account Code 2016-38000-6G00309STDSTD; and further authorizing the expenditure of same for the Collins Park Stream Restoration Engineering & Design project.

SECTION 4. That the Mayor is authorized to accept bids and execute necessary contracts related to this grant upon such terms and conditions as shall be approved by the Director of Public Utilities and the Director of Law.

SECTION 5. That the Director of Finance is authorized to issue their warrant or warrants against the Account Code above in amounts not to exceed those authorized above in payment of the obligations incurred pursuant to the above-authorized contracts upon presentation of proper voucher or vouchers.

SECTION 6. That this Ordinance is declared to be an emergency and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health, safety and property of the city and for the further reason that this ordinance must be immediately effective in order to implement this program within the funding agency's designated time schedule.
