SUMMARY & BACKGROUND:

An application (Z-11002-17) for a proposed change in zoning for the property located at 4915-4925 Douglas Road, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On January 11, 2018, the Toledo City Plan Commission recommended approval of the request for a zone change from "CR" Regional Commercial to "RS6" Single Family Residential for the property located at 4915-4925 Douglas Road, Toledo, Ohio.

The City Council Zoning and Planning Committee on February 14, 2018, sent as approved the request for a zone change from "CR" Regional Commercial to "RS6" Single Family Residential for the property located at 4915-4925 Douglas Road, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:
