Purchase of Mobile Camera Trailers Toledo Police Department Lt. James Brown (x3203) Revised

Authorizing the Mayor to enter into a contract with Fedtech LLC for the purchase of two mobile camera trailers for the Real Time Crime Center; authorizing the expenditure of \$129,854 from the Law Enforcement Trust Fund; and declaring an emergency.

SUMMARY & BACKGROUND:

This ordinance authorizes the expenditure of \$129,854 from the Police Law Enforcement Trust Fund for the purchase of two mobile camera trailers for the Real Time Crime Center. Bids for the trailers were posted on Planet Bids and Fedtech LLC was the sole bidder.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into a contract with Fedtech LLC to purchase two mobile camera trailers.

SECTION 2. That the sum of \$129,854 is authorized for expenditure from Account Code 2090-52000-3T32302STDSLC (Law Enforcement Trust Fund).

SECTION 3. That the Finance Director is authorized to draw warrant or warrants against the above mentioned Account Code in an amount not to exceed \$129,854 for the purchase of two mobile camera trailers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall be in force and

effect from and after its passage. The reason for the emergency lies in the fact that it is necessary for the immediate preservation of the public peace, health, safety, and property and for the further reason that this ordinance must be immediately effective in order to timely purchase additional cameras for public safety.
