SUMMARY & BACKGROUND:

An application (Z-5003-18) for a proposed change in zoning for the property located at 2746 W Laskey Road, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On July 12, 2018, the Toledo City Plan Commission recommended disapproval of the request for a zone change from "RS6" Single Family Residential to "CN" Neighborhood Commercial for the property located at 2746 W Laskey Road, Toledo, Ohio.

The City Council Zoning and Planning Committee on August 15, 2018, sent as disapproved the request for a zone change from "RS6" Single Family Residential to "CN" Neighborhood Commercial for the property located at 2746 W Laskey Road, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, are hereby authorized to be revised by changing the zone districts of that part of the City of Toledo more fully described as follows:

SECTION 2. The Secretary of the Toledo City Plan Commission is hereby authorized and directed to make the said change on the original zoning maps.
