# Changing the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, for the property located at 732 Main Street, in the City of Toledo, Lucas County, Ohio; and declaring an emergency.

### SUMMARY & BACKGROUND:

An application (Z-6005-18) for a proposed change in zoning for the property located at 732 Main Street, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On August 9, 2018, the Toledo City Plan Commission recommended approval of the request for a zone change from "CO" Office Commercial to "CR" Regional Commercial for the property located at 732 Main Street, Toledo, Ohio.

The City Council Zoning and Planning Committee on September 12, 2018, sent as approved the request for a zone change from "CO" Office Commercial to "CR" Regional Commercial for the property located at 732 Main Street, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, are hereby authorized to be revised by changing the zone districts of that part of the City of Toledo more fully described as follows:

### GARNERS ADDITION LOT 5 S 5 FT & LOTS 6 & 7 & N 36 FT LOT 8

SECTION 2. The Secretary of the Toledo City Plan Commission is hereby authorized and directed to make the said change on the original zoning maps.

SECTION 3. That this Ordinance hereby is declared to be an emergency measure and shall be in force and effect from and after its passage.
