**Authorizing the Mayor to accept a State Homeland Security Regional Grant from Lucas County EMA in an amount not to exceed \$34,313.33 for the City of Toledo, Fire and Rescue Department; authorizing the deposit, appropriation and expenditure of funds; and declaring an emergency.**

### SUMMARY & BACKGROUND:

Lucas County Emergency Management Agency has awarded the Toledo Fire and Rescue Department a State Homeland Security Regional Grant not to exceed \$34,313.33. These funds are to be utilized to for Toledo Fire and Rescue Department CBRNE HazMat Sustainment.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into a grant agreement with Lucas County Emergency Management Agency and to accept and deposit State Homeland Security Regional grant funds in an amount not to exceed \$34,313.33 into the Operation Grants Fund Account Code 2016-53000-3G00403STDSTD CBRNE HazMat Sustainment.

SECTION 2. That the sum of \$34,313.33 is appropriated from the unappropriated grant proceeds of the Operation Grants Fund to Account Code 2016-53000-3G00403STDSTD; and further authorizing the expenditure of the same for Toledo Fire and Rescue Department CBRNE HazMat Sustainment.

SECTION 3. That the Director of Finance is authorized to draw her warrant or warrants against the above Account Code in an amount not to exceed \$34,313.33 in payment of the obligations authorized above upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that it is necessary for the immediate preservation of the public peace, health, safety and property on a homeland security basis.
