An application (Z-8003-18) for a proposed change in zoning for the property located at 2517 W. Sylvania Avenue, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

Changing the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, for the property located at 2517 W. Sylvania Avenue, in the City of Toledo, Lucas County, Ohio; and

On October 11, 2018, the Toledo City Plan Commission recommended approval of the request for a zone change from "CO" Office Commercial to "RD6" Duplex Residential for the property located at 2517 W. Sylvania Avenue, Toledo, Ohio.

The City Council Zoning and Planning Committee on November 14, 2018, sent as approved the request for a zone change from "CO" Office Commercial to "RD6" Duplex Residential for the property located at 2517 W. Sylvania Avenue, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, are hereby authorized to be revised by changing the zone districts of that part of the City of Toledo more fully described as follows:

DE VEAUX PARK LOT 17 EXC PT IN RD

SECTION 2. The Secretary of the Toledo City Plan Commission is hereby authorized and directed to make the said change on the original zoning maps.

SECTION 3. That this Ordinance hereby is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that same is necessary for the immediate preservation of the public
