## SUMMARY & BACKGROUND:

This ordinance authorizes the expenditure of funds for a contribution to the Opioid Overdose Reduction Program. Funds will be re-appropriated within the Police department's 2018 operating budget to make this contribution this year.

SECTION 1. SECTION 2. That the expenditure of \$35,000 is authorized from the General Fund Account Code 1001-52000-558900-3381002STDSTD for a contribution to the Opioid Overdose Reduction Program through the University of Toledo Medical Center.

SECTION 3. That the finance director is authorized to draw warrant or warrants against the above account code in payment of the obligations authorized above in amount not to exceed \$35,000 upon receipt of
