## SUMMARY & BACKGROUND:

An application (Z-12002-18) for a proposed change in zoning for the property located at, 2215 Oak Grove Place, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On February 14, 2019, the Toledo City Plan Commission recommended approval of the request for a zone change from "CR" Regional Commercial to "RS6" Single Family Residential for the property located at 2215 Oak Grove Place, Toledo, Ohio,

The City Council Zoning and Planning Committee on March 20, 2019, sent as approved the request for a zone change from "CR" Regional Commercial to "RS6" Single Family Residential for the property located at 2215 Oak Grove Place, Toledo, Ohio.
