Authorizing the appropriation of \$75,000 from the unappropriated balance of the General Fund for an additional position in the Clerk of Council Office; authorizing the expenditure of said funds; and declaring an emergency.

SUMMARY & BACKGROUND:

City Council desires to appropriate \$75,000 this year for an additional position in the Clerk of Council Office for outreach to the community. This appropriation would add a position of Administrative Specialist 3 to act on City Council initiatives as they come forward. Funds are available within the General Fund.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the sum of \$75,000 is appropriated from the unappropriated balance of the General Fund to various account codes within 1001-10100-1112001STDSTD (City Council) for an additional position in the Clerk of Council Office and the expenditure of same is authorized for the year 2019.

SECTION 2. That an additional position of Administrative Specialist 3 is authorized and funded in Account Code 1001-10100-1112001STDSTD.

SECTION 3. That the Director of Finance is authorized to draw warrant or warrants against the above account code in payment of the listed obligations and upon presentation of proper voucher or vouchers.
