SUMMARY & BACKGROUND:

The Assessment Equalization Board appointed by Resolution No. 261-20 adopted July 21, 2020 to hear and determine all objections to the estimated special assessments for the cost of providing certain enhanced public services in the Revised Downtown Toledo Improvement District described in the Petition filed with this Council on June 30, 2020, and the related Services Plan filed with this Council on June 30, 2020 and approved by Resolution No. 262-20, adopted by this Council on July 21, 2020 (collectively, the Comprehensive Plan), has filed its report with this Council as to its determination of the objections.

Council has reviewed that report and deems it proper in all respects.

NOW, THEREFORE, Be it resolved by the Council of the City of Toledo:
