SUMMARY & BACKGROUND:

An application (Z-7002-20) for a proposed change in zoning for the property located at 20 N. St. Clair Street, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On September 10, 2020, the Toledo City Plan Commission recommended approval of the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 20. N. St. Clair Street, Toledo, Ohio.

On October 14, 2020, the Toledo City Council sent without recommendation the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 20. N. St. Clair Street, Toledo, Ohio.
