SUMMARY & BACKGROUND:

An application (Z-10005-20) for a proposed change in zoning for the property located at 3837 Secor Road, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On December 3, 2020, the Toledo City Plan Commission recommended approval of the request for a zone change from "CO" Office Commercial to "RM36" Multi Dwelling Residential for the property located at 3837 Secor Road, Toledo, Ohio.

On January 6, 2021, the Toledo City Council sent without recommendation the request for a zone change from "CO" Office Commercial to "RM36" Multi Dwelling Residential for the property located at 3837 Secor Road, Toledo, Ohio.
