Authorizing the Mayor to enter into an extension with OptumRx for the provision of pharmacy benefit management services for the City of Toledo covered employees for a term of fifteen (15) months; authorizing the expenditure of funds; and authorizing the waiver of competitive proposal and bidding requirements under Toledo Municipal Code Chapter 187; and declaring an emergency.

SUMMARY & BACKGROUND:

The City's pharmacy benefit management services contract with OptumRX, the current provider, expires on February 28, 2021. The current agreement can be extended until May 31, 2022.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to extend the Agreement with OptumRX for the provision of pharmacy benefit management services for a period of fifteen (15) months; and the expenditure of funds is authorized. The competitive proposal and bidding requirements under Toledo Municipal Code Chapter 187 are waived. Such Agreement shall contain terms and conditions deemed proper and requisite according to the Director of Law and the Director of Human Resources.

SECTION 2. That expenditures for pharmacy benefit management services are authorized from Account Code 7083-17100-537410-1156001STDSTD. That said costs shall then be allocated to Account Code 517400 (Medical Insurance) within the various City organization units.
