**Authorizing the appropriation and expenditure of an amount not to exceed \$800,000 from the unappropriated balance of the Sewer Replacement Fund for various sewer replacement projects; authorizing the mayor to prepare plans and specifications, acquire rights-of-way and easements as necessary, accept bids and enter into contracts; and declaring an emergency.**

### SUMMARY & BACKGROUND:

This ordinance funds the replacement of broken and deteriorated sewers throughout the city. This work is necessary to maintain safe, reliable service to the citizens.

The fiscal impact of this ordinance is as follows:

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That an amount not to exceed \$800,000 is appropriated from the unappropriated balance of the Sewer Replacement Fund into Account Code 6073-35000-4UC0821STDSTD; and the expenditure of the same is authorized for the replacement of broken and deteriorated sewers throughout the city.

SECTION 2. That the mayor is authorized to prepare plans and specifications, accept bids, and enter into contracts for said projects including such items as labor, materials, real estate incidentals, testing, purchase of rights-of-way and easements, equipment and professional services necessary to undertake said projects. Contracts shall contain such terms and conditions as the mayor may deem requisite and proper, and shall be subject to approval by the Director of Law and the Director of Public Utilities.

SECTION 3. That the Director of Finance is authorized to issue warrant or warrants against the account code listed in Section 1 in an amount not to exceed \$800,000 in payment of the above authorized obligations upon presentation of the proper voucher or vouchers.

SECTION 4. That the disappropriation of any remaining budget to fund balance is authorized at project closeout.

SECTION 5. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that this Ordinance must be immediately effective in order to permit the earliest possible construction of the sewer replacements.

Vote on emergency clause: yeas 12, nays 0.
