Glass City River Wall Office of the Mayor Gretchen DeBacker ext. 1600

Authorizing the expenditure of \$100,000 from the General Fund for the Glass City River Wall mural; authorizing the Mayor to enter into an agreement with the Toledo Community Foundation; and declaring an emergency.

SUMMARY & BACKGROUND:

The 2021 general fund operating budget includes funds for a contribution towards the Glass City River Wall mural. The mural will be on the silos at the port and will be completed in time for Solheim Cup. The total mural cost is \$600,000, with the City contributing \$100,000 of this total. Funds will be paid to the Toledo Community Foundation.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That an expenditure of \$100,000 is authorized from the General Fund, Account Code 1001-60500-7000301STDSTD for payment to the Toledo Community Foundation for the Glass City River Wall mural.

SECTION 2. That the Mayor is authorized to enter into an agreement with the Toledo Community Foundation for the Glass City River Wall mural, upon terms and conditions acceptable to the Director of Law.

SECTION 3. That the Finance Director is authorized to draw warrant or warrants against the abovementioned Account Code in an amount not to exceed \$100,000 in payment of the above authorized obligations upon the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that this ordinance is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that this ordinance must be immediately effective in order to timely provide support for the Glass City River Wall.

Vote on emergency clause: yeas 12, nays 0.

Passed: May 11, 2021, as an emergency measure: yeas 12, nays 0.
