Changing the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, for the property located at 3810 Angola Road, in the City of Toledo, Lucas County, Ohio; and declaring an emergency.

SUMMARY & BACKGROUND:

An application (Z-9001-21) for a proposed change in zoning for the property located at 3810 Angola Road, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On November 4, 2021, the Toledo City Plan Commission recommended disapproval of the request for a zone change from "RS6" Single Dwelling Residential to "CR" Regional Commercial for the property located at 3810 Angola Road, Toledo, Ohio.

On December 8, 2021, the Toledo City Council sent with a recommendation of disapproval the request for a zone change from "RS6" Single Dwelling Residential to "CR" Regional Commercial for the property located at 3810 Angola Road, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, are hereby authorized to be revised by changing the zone districts of that part of the City of Toledo more fully described as follows:

<u>LEGAL DESCRIPTION - 3810 ANGOLA ROAD, TOLEDO, OH</u> THE EAST ONE HUNDRED NINETY-FIVE AND SEVENTY HUNDREDTHS (195.70) FEET OF THE WEST FOUR HUNDRED TWENTY-FOUR (424) FEET OF THE SOUTH ONE-HALF (1/2) OF THE EAST ONE-HALF (1/2) OF THE SOUTHWEST ONE-QUARTER (1/4) OF THE SOUTHEAST ONE QUARTER (1/4) OF SECTION SEVEN (7), TOWN THREE (3) IN THE UNITED STATES RESERVE OF TWELVE (12) MILES SOUARE IN THE CITY OF TOLEDO, LUCAS COUNTY, OHIO.

SITUATED IN THE STATE OF OHIO, COUNTY OF LUCAS, CITY OF TOLEDO, FRACTIONAL SECTION SEVEN (7), TOWN THREE (3), UNITED STATES RESERVE AND ALSO BEING ON THE LEFT SIDE OF A SURVEY OF STATE ROUTE 2, (AIRPORT HIGHWAY), MADE IN 2002 FOR THE OHIO DEPARTMENT OF TRANSPORTATION AS RECORDED IN INSTRUMENT NUMBER 200401060000823 OF THE RECORDS OF LUCAS COUNTY AND BOUNDED AND DESCRIBED AS FOLLOWS:

SECTION 3. That this Ordinance hereby is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that same is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that the Ordinance must be immediately effective in order to provide for the orderly regulation and use of the property and to protect the land value in the area.
