## SUMMARY & BACKGROUND:

The City has strong interests at the state level, including an interest in the composition of the state budget and legislation that impacts the operations of local government, Toledo's interests must be adequately represented in the capital.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the mayor is authorized enter into a professional consulting services agreement with Shumaker Advisors, LLC, for a term of one year with the option for the City to renew for two additional one-year terms, to provide the city of Toledo with government affairs services. Such agreement shall contain terms and conditions deemed proper and requisite according to the Director of Law.
