## SUMMARY & BACKGROUND:

This Ordinance authorizes expending an amount not to exceed \$400,000 from appropriated CIP funds included in the approved 2022-2026 Capital Improvement Plan for the replacement of two (2) chillers located at the Ottawa Park ice rink.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That an expenditure in an amount not to exceed \$400,000 is authorized from the Capital Improvement Fund Account Code 5040-26100-8CP2207ICERNK for the purchase and installation of two (2) Chillers for the Ottawa Park ice rink.

SECTION 2. That the Mayor is authorized to accept bids and award contracts for the purpose specified in Section 1, upon terms and conditions acceptable to the Director of Law and the Director of Public Service.

SECTION 3. That the Director of Finance is authorized to draw his or her warrant or warrants against
