2022 Clean Toledo Recycling Events

Authorizing the expenditure not exceed \$500,000 for the collection, hauling, and processing of materials collected through the 2022 Clean Toledo Recycling events; authorizing the mayor to accept bids and enter into necessary contracts for recycling and disposal services; waiving the competitive procurement requirements of TMC Section 187; and declaring an emergency.

## SUMMARY & BACKGROUND:

The Division of Urban Beautification, in partnership with the Departments of Public Service, Public Utilities, and Engage Toledo, will increase the number of scheduled recycling events in 2022. These events are open to the public and provide the opportunity for participants to engage with a variety of vendors for recycling materials, hazardous waste, tires, televisions and other various electronics, personal documents, and general debris. The ordinance will authorize the expansion of the 2022 from twenty-three (23) total events to twenty-four (24), and support the large volume of materials collected for proper recycling for the on-site vendors.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the expenditure of an amount not to exceed \$500,000 is authorized from the General Fund, Account Code 1001-27100-1123001STDSTD, for the collection, hauling and processing of materials collected through the 2022 Clean Toledo recycling events.

SECTION 2. That the mayor is authorized to enter into agreements for the purpose identified in Section

1 and upon such other terms and conditions acceptable to the Director of Public Service and the Director of Law.

SECTION 3. That this Council finds it in the best interest of the city to waive the competitive procurement requirements of TMC Section 187 for the reason that with respect to the tire recycling component of the program there currently exists a vendor under contract with the City of Toledo for the Hoffman Road Landfill and the paint, electronic waste and document shredding vendors utilized in the 2021 program are able to maintain historic unit pricing and meet anticipated increased in material volume.

SECTION 4. That the Finance Director is authorized to draw their warrant or warrants against the above account code in payment of all obligations authorized above in an amount not to exceed \$500,000 upon presentation of proper voucher or vouchers.

SECTION 5. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property, and for further reason that the Ordinance must be immediately effective in order to allow the timely execution of the recycling events this year.
