## SUMMARY & BACKGROUND:

An application (Z-2009-22) for a proposed change in zoning for the property located at 12 N. St. Clair St., Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On April 14, 2022, the Toledo City Plan Commission recommended approval of the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 12 N. St Clair Street, Toledo, Ohio.

On May 18, 2022, the Toledo City Council sent with a recommendation of approval of the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 12 N. St Clair Street, Toledo, Ohio.
