Authorizing the Mayor to enter into a contract for the purchase of ballistic shields; authorizing the expenditure in an amount not to exceed \$69,000 for the purchase of ballistic shields from the Law Enforcement Trust Fund; and declaring an emergency.

SUMMARY & BACKGROUND:

This ordinance authorizes the expenditure of \$69,000 from trust funds for the purchase of ballistic shields from LC Action Police Supply, Ltd. Bids were solicited through Planet Bids and LC Action Police Supply, Ltd was the winning bidder.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the amount not to exceed \$69,000 is authorized for expenditure from the Law Enforcement Trust Fund Account Code 2090-52000-3T32302STDSLC for the purchase of ballistic vests.

SECTION 2. That the Mayor is authorized to enter into a contract for the purposes authorized in Section 1, upon terms and conditions acceptable to the Director of Police and the Director of Law.

SECTION 3. That the Finance Director is authorized to draw their warrant or warrants against the above referenced Account Code in payment of the obligation authorized in Section 1 in an amount not to exceed \$69,000 and upon presentation of proper voucher or vouchers.
