Changing the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, for the property located at 413-433 13<sup>th</sup> Street and 420-430 14<sup>th</sup> Street, in the City of Toledo, Lucas County, Ohio; and declaring an emergency.

## SUMMARY & BACKGROUND:

An application (Z-3003-22) for a proposed change in zoning for the property located at 413-433 13<sup>th</sup> Street and 420-430 14<sup>th</sup> Street, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On May 12, 2022, the Toledo City Plan Commission recommended approval of the request for a zone change from "IL" Limited Industrial to "CM" Mixed Commercial for the property located at 413-433 13<sup>th</sup> Street and 420-430 14<sup>th</sup> Street, Toledo, Ohio.

On June 15, 2022, the Toledo City Council sent with a recommendation of approval the request for a zone change from "IL" Limited Industrial to "CM" Mixed Commercial for the property located at 413-433 13<sup>th</sup> Street and 420-430 14<sup>th</sup> Street, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:
