Authorizing the expenditure of \$75,361.20 from the Capital Improvement Fund District Improvement Program for the Military Memorial Path at Bay View Park; authorizing the Mayor to execute the necessary contract; and declaring an emergency.

SUMMARY & BACKGROUND:

The Military Memorial Pathway submitted a District Improvement Program application for the Military Memorial Path at Bay View Park. The District Improvement Review Committee convened on October 26, 2022, and recommended approval of this application in an amount of \$75,361.20.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That a sum of \$75,361.20 is authorized for expenditure from Account Code 5040-16400-8CP2132DNGPRO for the District Improvement Program, Military Memorial Path at Bay View Park.

SECTION 2. That the Mayor is authorized to execute the necessary contract for the District Improvement Program, Military Memorial Path at Bay View Park, upon such terms and conditions as shall be approved by the Director of the Department of Economic Development, the Director of Parks & Youth Services, and the Director of Law.

SECTION 3. That the Director of Finance is authorized to draw warrant or warrants against the above account code in payment of the above authorized obligations in an amount not to exceed that authorized in Section 1 upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in

force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property and so that this project can be initiated as soon as possible for the Military Memorial Path at Bay View Park.
