Authorizing the expenditure of \$100,000 from the Capital Improvement Fund District Improvement Program for a new playground at Elmhurst Park; authorizing the Mayor to execute the necessary contract; and declaring an emergency.

SUMMARY & BACKGROUND:

A District Improvement Program application has been submitted to provide funding for a new playground at Elmhurst Park located at 4553 Garrison Road.

The District Improvement Review Committee convened on October 25, 2024, and recommended approval of this application in an amount of \$100,000.

NOW THEREFORE Be it ordained by the Council of the City of Toledo:

SECTION 1. That a sum of \$100,000 is authorized for expenditure from Account Code 5040-10100-8CP2318DNGPRO from the District Improvement Program for a new playground at Elmhurst Park.

SECTION 2. That the Mayor is authorized to execute the necessary contract from the District Improvement Program, upon such terms and conditions as shall be approved by the Director of the Department of Economic Development, the Director of Parks and Youth Services, and the Director of Law.

SECTION 3. That the Director of Finance is authorized to draw warrant or warrants against the above account code in payment of the above authorized obligations in an amount not to exceed that authorized in Section 1 upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property and for the further reason that this Ordinance must be immediately effective to install the playground in a timely manner.

Vote on emergency clause: yeas 12, nays 0.

Passed: November 6, 2024, as an emergency measure: yeas 12, nays 0.
