Authorizing the expenditure of \$302,750 from the Judges' Special Projects Trust Fund for the renovations of the Court Services office on the second floor of the Toledo Municipal Court; authorizing the Mayor to accept bids and award contracts for labor, materials and professional services necessary to complete said project(s); and declaring an emergency.
