Declaring the necessity and intention of appropriating a highway easement across a portion of the property owned by American 1st Title Agency, Inc., Trustee, located at 4576 River Road for the Anthony Wayne Trail Improvement Project (Detroit to Glendale); and declaring an emergency.

SUMMARY & BACKGROUND:

The city is proceeding with the Anthony Wayne Trail Improvement Project, which will include a complete reconstruction and lane reduction of the Anthony Wayne Trail (Lucas County Route 25) roadway from Detroit Avenue to Glendale Avenue, as well as the construction of multi-use path and utility improvements, which will better meet the current needs of the public and enhance the aesthetic appearance in this area. The project will require the purchase of a highway easement, of 3.3245 acres, more or less, across a portion of the property located at 4576 River Road, from American 1st Title Agency, Inc., Trustee. Negotiations with American 1st Title Agency, Inc., Trustee have been unsuccessful to date and it is now necessary to begin appropriation proceedings to protect the city's interest in the right-of-way to be acquired and keep the project on schedule.
