PYS American Rescue Plan Allocation 2022 Youth Engagement Plan Parks and Youth Services Joe Fausnaugh (x3884)

Authorizing the appropriation and expenditure of \$2,000,000 from the Local Fiscal Recovery Fund for 2022 youth engagement, mentoring, and development initiatives; authorizing the Mayor to enter into necessary agreements for these initiatives; and declaring an emergency.

SUMMARY & BACKGROUND:

The city is the recipient of \$180.9 million through the American Rescue Plan Act (ARPA) to be used to address the public health and negative economic impacts of the COVID-19 pandemic. The Toledo Recovery Plan framework (authorized by Ordinance 530-21), which outlines the city's projects that will be funded through ARPA, includes \$6,000,000 for youth and recreational programming. This Ordinance authorizes the appropriation and expenditure of \$2,000,000 of this amount for youth engagement, mentoring, and development initiatives in 2022. Funds will be used to support youth programming through grants distributed to community partners and by the Parks, Recreation and Community Enrichment Division. Specific programs targeted for funding are outlined in Schedule A.

NOW THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the appropriation of \$2,000,000 is authorized from the unappropriated balance of the Local Fiscal Recovery Fund to Account Code 2021-40100-7YOUTH and the expenditure of same is authorized for youth engagement, mentoring, and development initiatives as outlined in the Attached Schedule A.

SECTION 2. That the Mayor is authorized to enter into necessary program agreements with those individuals and entities identified in Schedule A, upon such terms and conditions as acceptable to the Director of Parks and Youth Services and the Director of Law.

SECTION 3. That the Mayor is authorized to accept bids and award contracts for the purposes specified in Section 1, upon such terms and conditions as acceptable to the Director of Parks and Youth Services and the Director of Law.

SECTION 4. That the Finance Director is authorized to draw warrant or warrants against the above Account Codes in payment of the above-authorized obligations in an amount not to exceed \$2,000,000 authorized upon presentation of the proper voucher or vouchers.

SECTION 5. That this Ordinance, being an emergency measure, shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the Ordinance is necessary for the immediate preservation of the public peace, health, safety and property and for the further reason that this Ordinance must be immediately effective in order to time initiate youth engagement, mentoring and development programs for 2022.

Vote on emergency clause: yeas 12, nays 0.

Passed: March 29, 2022, as an emergency measure: yeas 12, nays 0.
