2026 BUDGET PRIORITIES

Five Budget Priorities have been established to support the Mayor's Goal of increasing Toledo's population to 300,000 by the year 2040. Listed below are the five Budget Priorities:

- Deliver Exceptional City Services and Modernize Infrastructure
- Secure Toledo's Financial Future
- Cultivate a Thriving Workforce
- Build Safe, Vibrant and Connected Neighborhoods
- Promote Economic Growth and Inclusive Opportunity

The Plan Commission has been aligned with the Department of Economic Development as a means to provide a coordinated effort to achieving one of the five 2026 Budget Priorities. Several Objectives and Initiatives are being developed to assist in reaching the Mayor's goal. Those relevant to the Plan Commission include: initiating the rewrite of the zoning code, supporting adaptive reuse, identifying barriers to employment in the City's poorest neighborhoods, continuing to streamline development and permitting processes.

Maintaining our current staffing levels and continuing to develop and clarify the roles of the Plan Commission's internal divisions will allow our office to support these Objectives and Initiatives.







Toledo-Lucas County Plan Commissions 2025 Monthly Revenue Intake

















■ 2023 **■** 2024 **□** 2025
