



Upon arrival, this unit observed a ceramic decoration that had been exploded into pieces all over the front porch of the victims front porch. This unit also observed where the impact hit the wall and the explosive fragments surrounding the area. This unit spoke with victim Douglas Williams, who stated that he heard a boom outside his home before calling the police. Williams stated that he did not witness the explosion, but his home cameras were able to capture the footage. This unit viewed the video footage showing the listed vehicle approach the side of the residence and the two listed suspects get out of the car. One of the males that is later identified as, Seth Salmon, was seen lighting the object and then throwing it at the victims front door. The other unknown suspect was seen helping light the object and proceeded by filming the incident on his phone. This unit was able to identify the listed vehicle and followed up 2237 Caledonia, which is the registered owners address. Upon arrival, this unit observed the listed vehicle and watched Seth Salmon get out. Salmon was placed in to custody and put in the back of this unit's patrol vehicle. 3. Neither party shall initiate any contact with the other party or attempt to initiate any contact with the other party in-person or by any media including, but not limited to, writings, telephone, texting, e-mail, voice mail, or delivery service in person or through another person.
4. Neither party shall enter or interfere with the residence, place of worship, business, or place of employment of the other party, including the buildings, grounds and parking

lots at those locations. Neither party shall access or interfere with private records, medical providers, or assets of the other party.

5. Neither party shall cause or encourage any person to do any act which this order prohibits him from doing.





4. Defendant shall not cause or encourage any person to do any act which this order prohibits him from doing.
5. Defendant shall not enter or interfere with the residence, place of worship, business, or place of employment of the Plaintiff, including the buildings, grounds and parking lots at those locations. Defendant shall not access or interfere with private records, medical providers, or assets of the Plaintiff.

It is further ordered that this Agreed Order shall remain in effect through the following date: January 23, 2030, at which time the terms and conditions herein expire unless modified by the Court. No court costs shall be charged to either party.





On the listed date and time, this unit was called to 325 Whittemore for a criminal damaging complaint. Upon arrival, we spoke with Doug Williams who said someone was throwing firecrackers and shooting guns at his house. We looked at the side of the house and the area where Doug said the shots were fired and we did not see any evidence to suggest shots were fired. We did not find holes in the house and we did not find any shell casings. Doug said the neighbor down the street told him the suspects were shooting guns but he was unable to point out which neighbors told him that.

Doug did say he found a firecracker over the fence that was not exploded. When we reviewed the surveillance footage from the side of the house, two unknown suspects came up to the privacy fence and threw some firecrackers over the fence before fleeing on foot.
